# Open Meeting Opening Comments

Chris Berndt opened the meeting at 9:00 a.m.

# Roll Call

Roll call was taken and there was a quorum for scoring.

#### Approval of Agenda

JR Webb moved and Lynn Hollandworth seconded the motion to approve the agenda for the November 28, 2017 Region D RHSOC Scoring Meeting. Motion carried.

#### **New Business**

# FY17 Second Round Applications Q & A

Chris Berndt stated that they were here to allocate the remaining FY2017 funding of approximately \$71,000 with a second round of applications. He wanted to remind everyone that they could not score projects if they had conflicts of interest. This means that if a project is submitted by a jurisdiction that you

are part of, for example the City of Springfield, then no one who works for the City as police, fire, etc. can score that project. Dorothy Wittorff-Sandgren said that when a project is opened for scoring, there should be a question that asks if this is a conflict of interest and you hit yes.

Ms. Sandgren pointed out comments by OHS concerning the Bomb Squad Remote Firing Device. This piece of equipment is not allowed at this time. However, a request can be made to obtain a federal waiver if the bomb squad meets all of the requirements of IB 419, which is being worked on. The RHSOC still needs to score it. Also, OHS said that the Deputy Security Equipment for Dallas County Sheriff is a new project and not eligible for funding for this round since it is sustainment only. Members need to score it with all zeros. Chris Berndt went through each project and said to feel free to ask questions as we cover each one.

# **FY17 Second Round Applications Scoring**

Bomb Squad Remote Firing Device, \$26,000 – Springfield Fire Department

This device is to replace one that the bomb squad already has but part of which is broken. It provides the second remote firing capability to allow to split the team and to fire multiple shots at a single target to reduce the effect.

# Command Post Vehicle Sustainment, \$11,724.94 – Greene County Sheriff

This project is to provide funding to maintain voice and data communications equipment for the Region D Mobile CommandPost Vehicle. The application also contains requests funding to replace aged and failing equipment, specifically the cellular data modem.

# HSRRS General Sustainment, \$8,710 - Taney County EMA

The HSRRS Command vehicle is equipped to perform the role of research and reach back on a deployed CBRNE incident. The capability for internet connectivity was provided by a satellite service installed with FY2003 funding. The technology is outdated and unreliable. The current satellite network is unavailable and unsupported. The cellular internet connectivity provided through a case will allow the current capability to be maintained and restore internet connectivity in the field. Also, the Tactical MedKits for the Law Enforcement component of the Taney County/Branson HSRRS contain supplies with a shelf life which has ended. This purchase will sustain the current standard.

#### SWAT SCBA, \$19,422 - Joplin Police

In 2003, the Joplin SWAT team received funding for 18 SWAT Self Contained Breathing Apparatus (SCBA). This increases its ability to respond to critical incidents or to provide security after the initial incident, including events that would include a hazmat issue. There is also the potential to be required to respond to a Mobile Field Force incident in which a chemical agent has been introduced. The air tanks have a 15 year shelf life and will expire in 2018. In order to maintain this ability the SCBAs must be replaced.

# Water Rescue, \$9,154.25 – Joplin Fire

We were recently awarded a grant for the development of a Type II Swift Water Rescue Team in the Western part of Region D. We need to fund equipment for 5 additional personnel to ensure that we have adequate numbers to respond should an incident occur. When we first submitted the grant we only funded 5 personnel and have found we do not have enough PPE. We are requesting funding equipment for two 5 person teams to be able to respond.

MO Region D Communications Support Vehicle Sustainment, \$19,070 – Greene County OEM
This project will sustain this resource by replacing several pieces of older equipment at the end of life in order to maintain interoperable communications capabilities.

# Bomb Squad Robot Radio Assembly, \$44,068 - Springfield Fire

This project provides for the replacement of the existing radio transmitter for the Remotec F6B bomb disposal robot that was provided through the RHSOC. Originally purchased in 2010, the current radio system has declined in effective capability over the past several years of operation. This project would replace outdated technology similar to a wifi system (which does not meet the current standards) with a radio system which incorporates the use of FCC licensed dedicated transmission frequencies.

# HSRRS Personal Air Purifying Respirator, \$23,029 - Taney County EMA

The Law Enforcement component of the Taney County/Branson HSRRS initially purchased Personal Air Purifying Respirators (PAPR) with FY2002 funds. These respirators have reached the end of life and need to be replaced to sustain the capability the team has had since inception.

# HSRRS Bracing Materials, \$35,000 - Taney County EMA

Blocking and Bracing Materials were added as a capability of the Taney County/Branson HSRRS with the purchase of original equipment in the supplemental round of FY2003 funding and expanded in FY2005 funding. The manufacturer of the equipment/tools purchased is no longer in business or supporting the items. To sustain the capability and ensure reliable response the equipment needs to be updated.

# Bomb Squad EOD Bomb Suit, \$31,501 - Springfield Fire

The primary piece of safety equipment for a Bomb Tech is the bomb suit. The suit is designed to protect the wearer from blast injuries caused primarily by overpressure and fragmentation. While the manufacturer does not specify an exact expiration date, the accepted industry standard is that a bomb suit has a maximum service life of approximately 10 years. One of the required bomb suits is near the end of its useful service life. Having a manufactured date of February 2008, the suit should be removed from service in approximately 6 months. To maintain the current level of service a new bomb suit is required. The Med Eng EOD-10 is the current recognized standard for bomb suits in North America

# **Other Business**

Matt Stoller requested if he could change the line items on the FY16 Jasper County Communications Trailer project from 3 mobile radios to 2 mobile radios and one portable. Motorola has moved to a 4-way radio which can pick up MOSWIN, the local Joplin Police Department and UHF, which is used in Branson and some neighboring Kansas agencies. The prices have also gone down. He feels getting 2 mobiles and a portable is a better use of funding. Shea Lane moved and JR Webb seconded the motion to change the Jasper County Communication Vehicle project line item from 3 mobile radios to 2 and add a line item for a portable radio. Motion carried unanimously.
