Open Meeting

Opening Comments/Pledge of Allegiance

Election of Chair - David Hall

David Hall called for nominees for election of Region D RHSOC Chair. Russ Conroy nominated Chris Berndt for Region D RHSOC Chair and David Compton seconded. There were no other nominations. Motion carried unanimously. Chris Berndt will be the new Chair by vote of acclamation. Travis Trent will be the Primary member for HSRRS.

Election of Vice-Chair - David Hall

David Hall called for nominees for election of Region D RHSOC Vice-Chair. Chris Berndt nominated Lynn Hollandworth for Vice-chair and Gregg Sweeten seconded. Zim Schwartze also nominated David Pennington and Melissa Duckworth seconded. Lynn Hollandworth was elected Vice-chair by majority vote.

Committee Representatives Reports

RHSOC Chairs Meeting – David Hall

SEMA presented their list of courses to be funded with the FY19 grant. SEMA expects to be able to put on the following courses with FY19 RHSOC funding: eight ICS 300, eight ICS 400, one L964 All Hazard Situation Unit Leader, one L960 All Hazard Division/Group Supervisor, and two Homeland Security Exercise and Evaluation Program.

Region A Urban gave their presentation highlighting what they are doing with their Homeland Security funding. Much of it focused on the Complex Coordinated Terrorist Attack (CCTA) grant. They have been developing model procedures that can be duplicated in other jurisdictions across the country. This has been done through planning, training and exercises, so it is anticipated to be highly effective once prepared for distribution. They have also been conducting numerous exercises on a wide variety of other threats faced by the region.

Exercise/Training - Melissa Duckworth

Written report in handouts. Ms. Duckworth pointed out the upcoming trainings to be put on by SEMA. She reported that the Tabletop Exercise held on September 12 was a success. A Full-Scale Exercise is scheduled for October 31 from 9:00 a.m.-12:00 p.m.

WebEOC Group - Jonathan Ayres

The Region D WebEOC Administration Team had three meetings with SEMA and the Kansas City Region to resurrect the FUSION platform and connectivity to the State of Missouri WebEOC Platform, along with the Kansas City Region. Meetings were held in July, August, and September, when a change of staff at SEMA had occurred. No further information or dialog has been provided to Region D or the Kansas City Region by SEMA regarding FUSION connectivity. As always, those jurisdictions that would like to have training courses presented in their jurisdiction, please email in that request so that we can coordinate trainers and schedules.

Old Business

Homeland Security Grant Program Procurement Updates – Dorothy Wittorff-Sandgren

FY17: Everything for FY17 has been purchased and there is \$8,303.47 remaining to be returned to OHS. Joni McCarter said that the funds could go towards two more radios for Western Taney County Fire District and headphone equipment for the Telex project for the Greene County Communications Vehicle since the projects were split between FY17 and FY18, pending approval of the RHSOC. Since leftover money is to go towards Interoperable Communications, it is better to keep it in the region. Ron Bailey moved and Zim Schwartze seconded the motion to use the remaining funding to pay for the two radios for the Western Taney County Fire District project and the headphone equipment for the Greene County Telex project.

THIRA - David Hall

The first THIRA workshop was held on August 21. Participants were divided into groups, each covering one of the four scenarios provided by OHS. The scenarios were a Complex Coordinated Terrorist Attack, a Severe Weather System, a Pandemic, and a New Madrid Seismic event. They completed the first three steps of the THIRA process to establish capability targets. The second THIRA Workshop will be at the Community Room at Fire Station 8 on October 30 from 9:00 a.m. to noon. The SPR portion of the THIRA process will be completed at this meeting. This should complete the process. OHS wants the THIRA information back by November 15.

Inventory Requests - Dorothy Wittorff-Sandgren

Bob Patterson requested the disposition of 17 Motorola MC70 Semi-rugged Pocket PCs that were purchased with FY07 funds for Mercy EMS. They are outdated and can no longer be used. David Compton moved and Russ Conroy seconded the motion for the disposition of Mercy EMS's 17 Motorola MC70 Semi-rugged Pocket PCs. Motion carried unanimously.

New Business

No new business.

State Reports

OHS/HSGP Updates - Michelle Branson

Ms. Branson reminded everyone with projects funded with the FY19 grant that a Nationwide Cybersecurity Review (NCSR) was required in order to receive the funding. The proof of completion is due into OHS on December 15.

Interoperable Communications – Tom Charrette

Written report in handouts. Mr. Charrette emphasized that the dates, times and locations were still to be determined for the 2019 Training and Technical Assistance. Also, MO DPS sponsored Communications Vehicle Rodeo, Incident Communications Technician (COMT)/Communications Unit Leader (COML), and Incident Dispatch (INTD) planning is in process. The MO Field Operations Guide has been updated, and effective July 1 are Radio Interoperability Guidelines for radios and radio equipment. Finally, he stated that the Missouri Interoperability Center (MIC) is providing project and administrative support for the 911 Board.

DHSS - Douglas Baker

Not present. No report.

DNR Update - Carl Harris

Carl Harris reported that response protocol for DNR is evolving.

Agriculture Update – Dr. Larry Forgey

There has been another change in personnel. Greg Onstott is the Ag Manager.

Mutual Aid - Bob Patterson

Bob Patterson reported that all regions in the state have an EMS Mutual Coordinator appointed as well as Deputy Coordinators for Ground and Air. Region D's is Shane Vaughan. Jason Smith is the Deputy Coordinator for Ground EMS and DJ Satterfield for Air EMS. Bob Patterson is the Statewide Mutual Aid Coordinator. The team is active and meets monthly to review major responses, updates etc. Coordinators recently received multi-band portables to aid in responses using a dedicated statewide talk group.

IST – Scott Moore

Not present. Written report in handouts.

Annual Reporting

David Hall and Dorothy Wittorff-Sandgren explained that the Annual Reporting was started this year to coincide with the Annual Meeting to help the RHSOC in several ways. These numbers will be reported at the Annual Meeting first and foremost to let everyone know how much the funding has been used for the region. Since the scoring system has been changed so that we no longer have a Q&A meeting for those

applying for funds, this information can also be out there for future scorers to know how much the projects are being used and how important the project is for the region. This information will also be valuable for the future strategic plan. Ms. Sandgren added that the written reports need to be emailed to her so they can be compiled in one Annual Report that will be emailed out to everyone. The information is also important for OHS because they are required to report to the Feds, and we will have the information ready for them each year when requested. OHS would like the report by December 1, so Ms. Sandgren needs your written reports by the middle of November.

For the first report, Mr. Hall asked for numbers for the past three years and moving forward, it will only be annually. Several funding recipients that were present gave brief oral reports on their projects.

Disciplinary Group Reports

Volunteer Groups – Julie Stolting reported that there was a non-profit organization called 4-State Search and Rescue that had K9 dogs used for missing persons and water rescue. It is a local group out of Newton County, and they will travel around the states of Missouri, Arkansas, Oklahoma and Kansas. Shea Lane stated that a Disaster Preparedness 101 Course is available through the Catholic Charities of Southern Missouri.

Agriculture – David Cope reported that by January 1, 2023, cattle producers will be required to use RFID ear tags to identify livestock rather than the USDA metal tags when moving across state lines. Feeder cattle and others moving directly to slaughter are not subject to this new RFID requirements. Any cattle without RFID ear tags cannot move interstate and will have to be retagged, unless they are going straight to slaughter. This is designed to improve animal traceability through an animal disease outbreak. These tags will be read when animals go through an auction market, for example. If an animal is found to be diseased, it can be traced back to that auction market and from there to the previous location. Potential animals in contact there can also be looked at to see if they show signs of disease.

Other Business/Open Discussion

Tom Martin announced that Civil Air Patrol is available for events. Requests need to go through SEMA.

Next Meeting Date

The next meeting is scheduled to be held on January 15, 2020 at 9:00 a.m. Location will be the MU Southwest Research Center in Mt. Vernon.



MO SLIGP – FirstNet Update

- There are 1,200 approximately AT&T tower sites in Missouri
- 466 have installed FirstNet equipment and are broadcasting Band 14 (Band 14 = Black SIM card allowing for priority and preemption for public safety subscribers)
- And additional 152 will have Band 14 by the end of 2019 618 total
- 15,273 FirstNet subscribers in MO
 - o 2,351 are extended primary with Level 4 priority

- o 6,967 primary (agency paid) with Level 2. Priority Level 2 is highest priority level available until the device is elevated in the "Uplift Portal" during an incident
- o 5,897 subscriber-paid (non-agency paid) devices Level 3 priority
- 8,355 Black SIMS devices with Band 14 capability Recommended agencies should only purchase devices that are Band 14 capable to benefit from the public safety only spectrum AND FirstNet deployable site on wheels are Band 14 sites.

RHSOC Update/Annual Report

October 11, 2019

2019 has been a year of growth for the Southwest Missouri IST. We started off with several large projects in conjunction with new guidelines set by the Missouri Incident Management System and SEMA. These new guidelines required us to form committees with specific tasks:

SOG/Policy – This committee is reviewing our current SOGs and applying/adapting them to meet a higher standard. They also review the concept of operations to ensure we are working towards a common goal.

Logistics – To date, this group has had a heavy lift. They collaborated between the three recognized teams and developed an inventory within Salamander and generated an optimal cache of equipment for each team. SW IST was awarded EMPG funds through SEMA to help us achieve an adequate level of equipment and supplies to meet this standard. We are in the purchasing stage of this process.

Communications-IT – Working towards a common operating picture, this group looks at our current infrastructure and how we adapt to MOSWIN and other systems within the state. They are also part of the workgroup reviewing WebEOC for better use.

Credentialing – It is a goal to make credentialing in Missouri achievable and to provide integrity in the process. This group reviews request for credentialing and submits suggestions to the policy group for presentation to MIMS advisory.

Training – SEMA has taken a proactive approach to providing position specific training state-wide. This group looks to assist SEMA in located class needs and offerings around the country.


The MIMS advisory group was put on hold as the state dealt with flooding in almost every region. We have started back up as a group and are continuing to work towards the goal of strengthening the IST presence in Missouri.




